



Progress Over Pawfection LLC Nonprofit Fundraiser Contract for Shelters or Rescues

This contract ("Contract") is entered into between Progress Over Pawfection LLC, a limited liability company with its principal place of business at [Address] ("Fundraiser"), and [Shelter/Rescue Name], a shelter or rescue organization with its principal place of business at [Address] ("Organization").

1. Purpose:
